CAMP CLARK CAMBERSHIP INFORMATION

When applying for a campership you must complete all necessary documentation. **If we do not receive all the information completely filled out, we will not be able to process your application.** Even though the YMCA would like to assist everyone, please remember that our funds are limited and we need your assistance with this process. You can help us by returning all your information no later than the deadline of **May 17th, 2019**. Please submit all of the required paperwork to:

The following items are **required** in order for a campership to be awarded:

- Campership Application Form:** Completely filled out and signed by a parent/guardian.
- Camp Clark Registration (Forms A-E):** Completely filled out and signed by a parent/guardian.
- Physical and Immunization record**
- An entire month's worth of pay stubs:** Weekly equals 4 pay stubs; bi-weekly equals 2 pay stubs. If you receive assistance from **AFDC, SSI, or Child Support** this must be accounted for and verification must be submitted showing what you or any other member in the household receives in order for the application to be processed.

Keep in mind that there are many families in need of camperships. Your campership application will not be reviewed without all the required paperwork. We do not scholarship for specialty camps or the costs of extended care.

- You will be informed by **EMAIL** if your application has been approved or denied by **May 31, 2019**
- Camperships are awarded for **Weeks 2 and 3** and **Weeks 8 and 9**. We will do our best to accommodate your choice as best as we can.
- Because partial scholarships are awarded, you are required to pay your parent payment share at the time of acceptance (no later than **June 15, 2019**) **with no exceptions/deadlines.**
